**PURPOSE**

The purpose of this report is for Council to consider formal adoption of the Local Heritage Survey (LHS) and Heritage List following a period of public advertising.

**BACKGROUND**

The Department of Planning, Lands and Heritage (DPLH) announced a Local Heritage Grants Program in September 2022. The purpose of the grant was to identify local heritage places and develop and implement a heritage framework. In March 2023, Council was successful in receiving \$4,500 under this program.

Laura Gray of Heritage Intelligence (WA) was contracted to undertake works required to form a new Local Heritage Survey (LHS) which would replace Council’s previously adopted Municipal Heritage Inventory.

In April 2023, Laura provided a presentation to Council on the overview of the LHS process and met with locals within the Shire to discuss and assess identified places and potential places of heritage interest.

**PURPOSE**

The purpose of this report is for Council to consider being involved in the Endangered Carnaby’s Black Cockatoo Conservation Project being driven by Katanning Landcare.

**BACKGROUND**

An email has been received from Ms Paulley, Project Officer, Katanning Landcare seeking support for the Endangered Carnaby’s Black Cockatoo Conservation Project.

Katanning Landcare are working with South West Natural Resource Management (NRM) on the project and is looking to include the Shire’s of Katanning, Kent, Kojonup, Wagin and Woodanilling.

Other project partners are the Department of Biodiversity, Conservation and Attractions, Indigenous groups, community groups, and Birdlife Australia (Perth). Birdlife Australia believes Carnaby’s breed at or feed in the Kwobrup Nature Reserve but more research needs to be done to confirm this.

A project brief is attached as attachment 1.

**COMMENT**

The Katanning Landcare will be applying for funding through Lotterywest for support.

To support the Lotterywest funding application, Katanning Landcare are seeking contributions of cash or –in-kind. Ms Paulley provided an example that Council may wish to cover the cost of the 2-3 artificial nesting tubes that have been proposed for our Shire plus a contribution towards the monitoring camera.

Council are to consider if they wish to be involved in the project and what level of involvement. Supporting the project offers numerous benefits that align with the council’s objectives and responsibilities:

- **Biodiversity Conservation:** Carnaby’s Black Cockatoo is an iconic and endangered species native to our region. By supporting its conservation, council will contribute to preserving biodiversity and protecting a significant component of the local ecosystem.
- **Ecotourism and Recreation:** Carnaby’s Black Cockatoo is a draw for ecotourism and birdwatching enthusiasts.
- **Environmental Education:** The project provides opportunities for community engagement and environmental education. Through workshops, school programs, and public outreach efforts, the council can raise awareness about biodiversity conservation and foster a sense of environmental responsibility among residents.
- **Social Responsibility:** Conservation efforts contribute to the well-being of both present and future generations. By supporting the project, council demonstrates its commitment to social responsibility and sustainable development, enhancing its reputation as a conscientious and forward-thinking governing body

Providing a financial contribution towards the project not only serves to protect a critically endangered species but also aligns with the council's broader goals of environmental stewardship, community engagement, and sustainable development.
