#### 5. GENERAL BUSINESS

#### **Taryn Borgward**

The Annual Report is not formatted very nicely. Is it sent anywhere?

The Chief Executive Officer advised that it is placed on the Shire's website.

#### Tim Borgward

Back at the Centenary, there was a letter to the Shire about Lake Bryde. There was a matter to be written to the DBCA. Do we know what has happened?

The **President** advised that she was made aware of a matter from Parks and Wildlife in response to a letter sent by Peter Clarke, then Acting Chief Executive Officer. The reserves are managed by the Department of Water and Environmental Regulation and not the Department of Biodiversity, Conservation and Attractions and when contacted for comment, the current reserve purpose under the management order is for water supply not tourism or recreation.

#### **Tim Borgward**

A meeting with former Chief Executive Officer Peter Bentley suggested that it would be a ski park.

The **President** advised that the reserve is managed by DWER not DBCA and it is only for water supply. We aren't able to build facilities as it isn't part of the purpose.

#### **Taryn Borgward**

I lodged a complaint about a barking dog and did not receive a response from the Shire Ranger and there was no response.

The **Chief Executive Officer** took the question on notice and would follow the matter up.

#### **Taryn Borgward**

The Ranger isn't around enough. Is it possible for the Ranger to be around more often?

The **President** advised that she felt the Ranger is around more often.

# **Taryn Borgward**

This particular dog was tied up for ten days and there was no response from the Ranger. I would have thought a phone call would have happened.

The **President** advised that the Shire will follow that up as indicated in previous responses.

# **Joceline Dudgeon**

In relation to barking is there a simpler way to lodge complaints? We already had video footage. It seemed like a big process when the matter was raised.

The **Chief Executive Officer** advised that we need to have a paper trail to lodge these complaints but that doesn't mean we can't get the Ranger out straight way. We need to have it on paper to action.

# **Joceline Dudgeon**

Is it possible to get an email returned to show what is lodged? I wasn't sure it was received.

The Chief Executive Officer advised that the Shire will look into that.

#### **Tim Borgward**

Can we catch cats?

The **Chief Executive Officer** advised that people have caught cats in the past and the ranger has taken them away.

# **Tim Borgward**

Is it possible for Christie or David to spend a couple of hours out at the CRC or the like for Pingrup locals to talk to the Shire?

**The Chief Executive Officer** advised that this is not something that Council have given a direction on.

#### **Taryn Borgward**

Would the Shire President consider coming over to Pingrup for a couple of hours and make herself available?

The **President** advised that she doesn't do this in Nyabing either. She is always contactable by phone or email and is happy to talk. As with everyone she is also time poor with volunteer roles, family and a business to run.

#### **Tim Borgward**

It's easy for people to go up to Christie in the Pub in Nyabing to chat about shire issues.

The **Chief Executive Officer** responded by saying that she does not allow it as this is her personal time and directs them to contact the office.

The **President** advised when Christie is at the pub this is her personal time and should not be expected to deal with shire issues.

# **Tim Borgward**

I'm trying to encourage people this side of the shire to contact the shire more.

**Cr Scott Crosby** said that the Council and Shire representatives are here now and attendance is low. We have council meetings here and no one comes long. We've tried to change time and days and it's on the community WhatsApp.

# **Joceline Dudgeon**

Are Council meetings open to the public?

The **President** advised that all Council Meetings are open to the public and members of the public can attend at any time.

Could we have Council meetings on Zoom?

The **Deputy Chief Executive Officer** advised that we are now required to record Council Meetings and put them on the website. In relation to electronic meetings, theoretically a local government could do it, however public participation would not be allowed.

# **Taryn Borgward**

The town looks nice thank you very much. Suma did a nice post on the trail lights. Is the town going to be maintained to this standard?

The **Manager Infrastructure** advised that we are putting a program in place to address ongoing maintenance around the townsites.
